### Base Components of an Abatement Plan

A successful abatement plan will have multiple elements; programs to treat individuals with OUD, programs to reduce harms from opioid use, programs to prevent future opioid misuse, and coordination and monitoring of those efforts. A combination of efforts across all four buckets will be required to effectively abate the opioid epidemic.

These are representative best practices and policies that will be modeled and considered in our simulation model.






